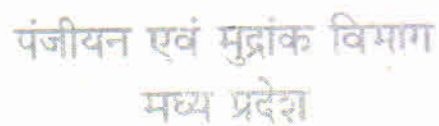

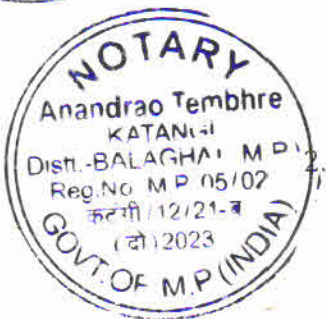
And whereas the commission in carrying out its objects and functions has sanctioned grant out of its funds to the said College.

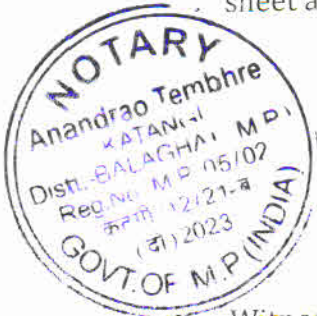
